Introduction

- Use of refurbished devices when possible

- Encouraging carpooling
- Walking/cycling where safe
- Awareness drives on low-emission travel

- Monthly sustainability newsletter
- Social media updates on green initiatives
- Training workshops for staff
- Sustainability Week events
- Display of sustainability goals and achievements across campus
