

1. Purpose

The purpose of this policy is to:

- Maintain a **drug-free school environment** that protects the health, safety, and academic success of all students.
- Safeguard students from the harmful effects of drugs, in line with **UAE Federal Laws** and **KHDA safeguarding requirements**.
- Provide a **clear framework** for prevention, early intervention, reporting, and management of drug-related cases.

2. Scope

This policy applies to:

- **All students, staff, and visitors** of New Indian Model School, Dubai.
- **School premises, school transport, and all school-organized activities** (including field trips, events, and competitions).
- Any **drug-related behavior outside school** that negatively impacts the safety, well-being, or reputation of the school community.

3. Definitions

- **Drug Abuse:** Possession, distribution, or use of illegal substances, or misuse of prescription/over-the-counter medications.
- **Illegal Substances:** Drugs and controlled substances prohibited under **UAE Federal Law No. 14 of 1995 on Narcotic Drugs and Psychotropic Substances**.
- **Rehabilitation:** Counseling, treatment, or support provided to students involved in drug misuse to promote recovery and reintegration.

4. Prevention & Education

The school is committed to proactive prevention through:

- **Awareness Campaigns:** Regular workshops, assemblies, and campaigns on the dangers of drug abuse.

- **Curriculum Integration:** Age-appropriate modules on health, well-being, and substance abuse prevention.
- **Parental Engagement:** Workshops for parents on recognizing warning signs and supporting children.
- **Collaborations:** Engagement with **UAE authorities and health professionals** for awareness and prevention programs.

5. Prohibition

The following are strictly forbidden:

- **Possession, use, or distribution** of illegal substances on or off school grounds.
- **Misuse of prescription medication** or over-the-counter drugs.
- **Promotion or glorification** of drugs in any form, including digital platforms or social media.

6. Intervention & Support

- **Counseling Services:** Students involved in drug-related cases will be offered **confidential counseling and rehabilitation support**.
- **Parental Collaboration:** Parents will be engaged immediately to support intervention strategies.
- **Referral:** In serious cases, the school may refer students to **external specialists** or UAE-approved rehabilitation centers.

7. Consequences

Drug abuse is a **serious violation** of school and UAE laws. Actions include:

- **Immediate disciplinary action** (warning, suspension, or expulsion based on severity).
- **Mandatory reporting** to UAE authorities, as required under federal law.
- **Legal consequences** in line with **UAE narcotics and child protection laws**.

- Compliance with this policy is mandatory for all community members.
- Violations are addressed through **consistent disciplinary action** aligned with KHDA safeguarding standards and UAE law.

10. Review

This policy will be **reviewed annually** by the **Senior Leadership Team** to ensure alignment with:

- **KHDA safeguarding standards**
- **UAE federal drug laws**
- **Evolving best practices in student well-being and child protection**

Any updates will be communicated to staff, students, and parents.
